INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (the “*Release*”), dated as of September 23, 2021, is made by JPMorgan Chase Bank, N.A., as collateral agent (in such capacity, the “*Collateral Agent*”) for the Secured Parties (as defined in the Credit Agreement referred to below) in favor of Executive Air Support, Inc. and Atlantic Aviation FBO Inc. (each a “*Grantor*”, and together, the “*Grantors*”).

WHEREAS, Atlantic Aviation FBO Holdings LLC, a Delaware limited liability company, Atlantic Aviation FBO Inc., a Delaware corporation (the “*Borrower*”), and certain subsidiaries of the Borrower entered into a Credit Agreement dated as of December 6, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*Credit Agreement*”), with the Collateral Agent and the Lenders party thereto. Terms defined in the Credit Agreement or the Guarantee and Collateral Agreement (as hereinafter defined) and not otherwise defined herein are used herein as defined in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable;

WHEREAS, each Grantor executed and delivered that certain Guarantee and Collateral Agreement, dated December 6, 2018, to the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*Guarantee and Collateral Agreement*”);

WHEREAS, pursuant to the terms of the Guarantee and Collateral Agreement, the Grantors executed that certain Intellectual Property Security Agreement, dated December 6, 2018, in favor of the Collateral Agent, which was recorded with the United States Patent and Trademark Office on December 17, 2018 at Reel 6502, Frame 0092 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*IP Security Agreement*”);

WHEREAS, pursuant to the terms of the IP Security Agreement, the Grantor granted to the Collateral Agent for the ratable benefit of the Secured Parties a lien on and security interest in all of such Grantor’s right, title and interest in and to the Collateral (as defined in the IP Security Agreement) listed on Schedule I;

WHEREAS, in accordance with that certain Pay-Off Letter dated September 23, 2021 and sent by the Collateral Agent (the “*Pay-Off Letter*”), the obligations secured by the Collateral have been repaid or otherwise satisfied to the extent set forth in such Pay-Off Letter;

WHEREAS, the Collateral Agent therefore now desires to release its security interest granted pursuant to the IP Security Agreement in and to the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby covenants and agrees as follows:

SECTION 1. The Collateral Agent does hereby, without representation or warranty of any kind, (i) release all of its right, title and interest in, to and under the Collateral listed on Schedule

I granted to the Collateral Agent pursuant to the IP Security Agreement and (ii) terminate the IP Security Agreement.


