Corporations Section

Pursuant to Chapter 10 of the Texas Business Organizations Code (the "TBOC"), the undersigned parties submit this Certificate of Merger.

1. *Parties.* The name and information required by the TBOC for each entity or organization that is a party to the merger is as follows:

Zodiac Spirits, LLC, is a Texas limited liability company. The Texas Secretary of State file number is 801894026. Its principal place of business is 8150 North Central Expy., Suite 1000, Dallas, Texas 75206. Zodiac Spirits, LLC will not survive the merger.

Snake River Spirits, Inc., is a Delaware corporation. The Delaware Secretary of State file number is 7429001. Its principal place of business is 8150 North Central Expy., Suite 1000, Dallas, Texas 75206. Snake River Spirits, Inc. will survive the merger.

2. *Agreement and Plan of Merger.* Instead of providing the agreement and plan of merger, each of the undersigned certifies that:

(a) An agreement and plan of merger is on file at the principal place of business of the surviving organization that is named in this Certificate of Merger as a party to the merger.

(b) On written request, a copy of the agreement and plan of merger will be furnished without cost by the surviving entity to any owner or member of any domestic entity that is a party to or created by the plan of merger.

(c) No amendments to the certificate of formation of the surviving filing entity that is a party to the merger are required as a result of the merger.
