Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademark registrations, to record this assignment, and to issue or transfer said Trademark to Assignee as owner of all right, title and interest therein, or otherwise as Assignee may direct.


