Upon said consideration, Assignor, its successors and assigns does hereby covenant and agree with the Assignee, its successors and assigns, that Assignor, its successors and assigns, will not execute any writing or do any act whatsoever conflicting with these presents and that Assignor, its successors and assigns, will at any time upon request, without further consideration, but at the expense of Assignee, its successors and assigns, execute such additional writings and do such additional acts as said Assignee, its successors and assigns, may deem necessary or desirable to perfect the Assignee's enjoyment of this grant.
