GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

This GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS ("Agreement"), dated as of August 31, 2021 is made by DANIEL OPCO, LLC, a Delaware limited liability company (the "Grantor") with principal offices at 575 Madison Avenue, Suite 1006, New York, NY 10022, in favor of CADENCE BANK, N.A. (the "Lender"), pursuant to that certain Guaranty and Collateral Agreement, dated as of August 31, 2021 (as amended, modified, restated, supplemented or otherwise modified from time to time, the "Guaranty and Collateral Agreement"), among Joule Intermediate, LLC (the "Holdings"), Daniel Opco, LLC (the "Company"), and other Grantors and Guarantors from time to time party thereto and the Lender.

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Grantor hereby grants to the Lender a continuing security interest in (i) all of the Grantor's right, title and interest in, to and under to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT is made to secure the satisfactory performance and payment of all the Obligations (as such term is defined in the Guaranty and Collateral Agreement) for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office.




