RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 17th day of August, 2021, by CapitalSource Finance LLC, as successor by merger to CapitalSource SF Finance LLC, which entity was dissolved effective December 30, 2010, as agent for Lenders (in such capacity, the "Agent").

WHEREAS, reference is made to that certain Patent, Trademark and Copyright Security Agreement dated as of January 12, 2007 and recorded with the United States Patent and Trademark Office beginning at **Reel 003461, Frame 0543** (the "IP Security Agreement"), by KASTLE SYSTEMS INTERNATIONAL LLC, a Virginia limited liability company and each of the other parties, namely, IH LEASING LLC, KASTLE ACQUISITION LLC, KASTLE AUSTRALIA LLC, KASTLE CHICAGO LLC, KASTLE DEVELOPMENT ASSOCIATES LLC, KASTLE HOLDING COMPANY LLC, KASTLE NEW YORK LLC, KASTLE PHILADELPHIA LLC, KASTLE SECURITY ASSOCIATES LLC, KASTLE SOFTWARE ASSOCIATES LLC, KASTLE SOFTWARE ASSOCIATES LLC, KASTLE SYSTEMS LLC, KASTLE SYSTEMS OF CALIFORNIA LLC, KASTLE SYSTEMS OF LOS ANGELES LLC AND KASTLE SYSTEMS OF TEXAS LLC, AND KASTLE SYSTEMS OF LOS ANGELES PARTNERSHIP (each a "Pledgor" and collectively "Pledgors"), in favor of Agent. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the IP Security Agreement.

WHEREAS, under the IP Security Agreement, Pledgors granted to Agent, for the benefit of itself and the Lender, a continuing security interest in all of the right, title and interest of such Pledgors in and to the Collateral (as defined in the IP Security Agreement), including, but not limited to, the Patents (or applications) and Trademarks (or applications) as set forth on Schedule A, attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby (i) releases and discharges any and all liens on, and its security interest in and to the Collateral, including the Patents (or applications) and Trademarks (or applications) set forth on Schedule A, attached hereto, and (ii) authorizes the recordation of this Release by Pledgors or its designee with the United States Patent and Trademark Office.


This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
