## ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY ("Assignment"), effective as of February 8, 2018 (the "Effective Date"), is entered into by and between **WestRock MWV, LLC**, a Delaware limited liability company ("Assignor"), and **WestRock Belgium SPRL**, a Belgian ~~limited liability company~~ ("Assignee"), hereinafter collectively referred to as the "Parties." *Societe Privée a Responsabilite Limitee (SPRL)*

WHEREAS, Assignor owns all right, title, and interest, in certain intellectual property identified in the attached Schedules A, B, and C (the "Assigned Intellectual Property"), including patents, trademarks, and internet domain names;

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, any and all rights that Assignor has in and to the Assigned Intellectual Property;

NOW, THEREFORE, in consideration of the promises and agreements set forth herein, and for other good and valuable consideration, the adequacy and sufficiency of which are hereby acknowledged, the Parties, each intending to be legally bound, hereby agree as follows:

1. Assignment of Rights. Assignor hereby irrevocably assigns and transfers to Assignee all right, title and interest throughout the world in and to:

a) the patents and any applications for patents listed in the attached Schedule A, including any continuation, division, renewal, substitute, reissue or extension thereof, and including all priority rights (collectively the "Patents"), together with all claims for past and future damages by reason of infringement of the same, with the right to sue for past and future damages and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives;

b) the registered trademarks and registrations therefor listed in the attached Schedule B (collectively the "Trademarks"), and all of the goodwill of the business symbolized by any of the Trademarks, with the right to sue for past and future damages and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives; and

c) the internet domain names listed in the attached Schedule C.

2. Assistance in Perfecting Assignment. Assignor expressly agrees that at any time hereafter, at the request of Assignee, Assignor shall take any and all reasonable steps and execute, acknowledge and deliver to Assignee any and all further instruments and assurances reasonably necessary or expedient in order to vest the rights described herein more effectively in Assignee. Upon the execution of this Assignment and at its expense, Assignor shall, as soon as reasonably possible, record the Assignment of the Patents and Trademarks with the




