**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of September 27, 2021 by Antares Capital LP, as administrative agent (the “*Assignee*”), in favor of OB Hospitalist Group, Inc., a Delaware corporation (the “*Grantor*”). Capitalized terms used in this Termination and Release and not herein defined shall have the meanings set forth in the Intellectual Property Security Agreement, referred to below.

**WHEREAS**, Grantor executed and delivered an Intellectual Property Security Agreement, dated as of August 1, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”) granting the Assignee a security interest in and lien on all of the trademarks included in the Trademark Collateral as described therein (“*Trademark Collateral*”);

**WHEREAS**, the Grant was recorded with the United States Patent and Trademark Office (“*USPTO*”) on August 1, 2017, at Reel 6120, Frame 0313;

**WHEREAS**, Grantor has requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademark Collateral as herein provided; and

**WHEREAS**, Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence such termination, release and discharge of the Assignee’s security interests in and liens on the Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Grant and releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its liens and security interests in the Grantor’s right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including, without limitation, those identified in Schedule I hereto;
2. agrees to take all further commercially reasonable actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such commercially reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s expense, to more fully effectively effectuate the purpose of this Termination and Release; and


3. authorizes and requests that this Termination and Release be recorded, at the Grantors' expense, at the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE INTERNAL LAWS (AND NOT THE CONFLICT OF LAW RULES) OF THE STATE OF NEW YORK.
