## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This **INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT** ("**IP Assignment**"), dated March 26, 2021, is entered into by and among Magnetrol International Holding Company, a Delaware corporation, Magnetrol International, Incorporated, a Delaware corporation, Introtek International, L.P., a Delaware limited partnership, Solutions with Innovation LLC, a Delaware limited liability company, and Orion Instruments, LLC, a Delaware limited liability company (collectively, the "**Assignors**"), to AMETEK DE, LLC, a Delaware limited liability company ("**Assignee**").

### BACKGROUND

Pursuant to that certain Asset and Stock Purchase Agreement (as amended, supplemented or otherwise modified from time to time, the "**Purchase Agreement**"), dated February 18, 2021, by and among AMETEK, Inc., a Delaware corporation, Magnetrol International Holding Company, a Delaware corporation, the other Sellers identified therein and the Stockholders identified therein, the (i) Assets Sellers have agreed to sell, convey, transfer and assign to the Assets Buyers (including Assignee) the Purchased Assets and (ii) each Assignor has agreed to sell, convey, transfer, and irrevocably assign and deliver to Assignee all right, title and interest in and to all of the Company Group Owned Intellectual Property owned by such Assignor, including any Company Group Names and any adaptations, derivations and combinations thereof and any trademarks that use or incorporate any of the Company Group Names, including the intellectual property set forth on Schedule I attached hereto (collectively, the "**Acquired Intellectual Property**").

### AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein and in the Purchase Agreement, and for other good and valuable consideration, the receipt and adequacy of which are hereby conclusively acknowledged, and intending to be legally bound hereby, the parties hereto hereby agree as follows:

### PATENTS

1. Each Assignor hereby sells, conveys, transfers, and irrevocably assigns and delivers to Assignee, free and clear of all Liens (other than Permitted Liens), all right, title and interest in and to the patents, patent applications and patent disclosures included in the Acquired Intellectual Property, and further including any and all (a) rights in any divisional, continuation, continuation-in-part, reexamination, or reissue thereof, (b) rights to obtain patent or equivalent protection therein in the United States and throughout the world, and (c) rights to sue and recover any and all damages and profits and seek injunctive and other equitable relief, and any and all other remedies, for past, present, or future infringements or other violations thereof, all in Assignee's sole name.

## **TRADEMARKS**

2. Each Assignor hereby sells, conveys, transfers, and irrevocably assigns and delivers to Assignee, free and clear of all Liens (other than Permitted Liens), all right, title and interest in and to the trademarks, service marks, trade dress, logos, trade names, corporate names and other distinctive identifiers of source included in the Acquired Intellectual Property together with the goodwill that is symbolized by those, and further including any and all (a) renewal rights in respect of such Acquired Intellectual Property, (b) rights to obtain registrations of such Acquired Intellectual Property in the United States and throughout the world, and (c) rights to sue and recover any and all damages and profits and seek injunctive and other equitable relief, and any and all other remedies, for past, present or future infringements or other violations thereof, all in Assignee's sole name.

## **COPYRIGHTS**

3. Each Assignor hereby sells, conveys, transfers, and irrevocably assigns and delivers to Assignee, free and clear of all Liens (other than Permitted Liens), all right, title and interest in and to the all works of authorship (whether or not copyrightable or published), copyrights and copyrightable works and all applications and registrations in connection therewith and all moral rights relating thereto included in the Acquired Intellectual Property, and further including any and all (a) renewal rights in respect of such Acquired Intellectual Property, (b) rights to obtain registrations of such Acquired Intellectual Property in the United States and throughout the world, and (c) rights to sue and recover any and all damages and profits and seek injunctive and other equitable relief, and any and all other remedies, for past, present or future infringements or other violations thereof, all in Assignee's sole name.

## **TRADE SECRETS**

4. Each Assignor hereby sells, conveys, transfers, and irrevocably assigns and delivers to Assignee, free and clear of all Liens (other than Permitted Liens), all right, title and interest in and to the all trade secrets and other confidential information (including inventions, know how, formulas, compositions, manufacturing and production process and techniques, methods, schematics, technology, technical data, designs, drawings, flowcharts, block diagrams, specifications, customer and supplier lists, pricing and cost information and business and marketing plans and proposals) of such Assignor, including any and all rights to sue and recover any and all damages and profits and seek injunctive and other equitable relief, and any and all other remedies, for past, present or future misappropriations or other violations thereof, all in Assignee's sole name.

## **MISCELLANEOUS**

5. Each Assignor hereby sells, conveys, transfers, and irrevocably assigns and delivers to Assignee, free and clear of all Liens (other than Permitted Liens), all right, title and interest in and to the all (a) domain names and social media accounts, (b) software and firmware (including data, databases and related documentation), (c) mask works and all applications, registrations and renewals in connection therewith, (d) all

documents, records and files relating to design, end user documentation, manufacturing, quality control, sales, marketing or customer support for, and tangible embodiments of, all Acquired Intellectual Property and (e) all other tangible or intangible proprietary information and materials, of such Assignor, including any and all rights to sue and recover any and all damages and profits and seek injunctive and other equitable relief, and all other remedies, for past, present or future misappropriations or violations thereof, all in Assignee's sole name.

#### FURTHER ASSURANCES

6. Each Assignor agrees, from time to time after the Closing to take any further action that is reasonably necessary or desirable to carry out the purposes of this IP Assignment, including to (i) execute and deliver further instruments of transfer, assumption and assignment and take such other actions as Assignee may reasonably require to transfer, assign to and vest in Assignee the Acquired Intellectual Property; (ii) cooperate with and provide assistance to Assignee in transferring possession of the Acquired Intellectual Property to Assignee at Assignee's sole cost and expense and (iii) do, execute, acknowledge and deliver or cause to be done, executed, acknowledged and delivered all and every further reasonable act, deed, conveyance, transfer and assurance necessary to assure such Assignor's compliance with the terms, provisions, purposes and intents of this IP Assignment and the effectiveness of the rights, and benefits provided for hereby, including the execution of any instruments and papers that are necessary or desirable, in Assignee's sole discretion, to consolidate, confirm, vest and/or record Assignee's full and complete ownership of the Acquired Intellectual Property with, for example, the United States Patent and Trademark Office.

#### GENERAL

6. Entire Agreement. This IP Assignment, the Purchase Agreement and the Ancillary Agreements constitute the entire agreement of the parties hereto with respect to the subject matter hereof and supersedes all prior agreements, representations, undertakings and understandings, both written and oral, among the parties hereto with respect to the subject matter hereof. All representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall survive the execution and delivery of this IP Assignment and shall continue in full force and effect as provided in the Purchase Agreement. Neither the making nor the acceptance of this IP Assignment or of any other instrument or document of sale, transfer, assignment, conveyance, acquisition or acceptance as to any particular Purchased Asset (including the Acquired Intellectual Property) shall restrict, impair, reduce, expand or otherwise modify the terms of the Purchase Agreement.

7. THE SALE, CONVEYANCE, TRANSFER, ASSIGNMENT AND DELIVERY CONTEMPLATED BY THIS IP ASSIGNMENT SHALL BE WITHOUT REPRESENTATION OR WARRANTY OF ANY KIND BY THE TRANSFERORS EXCEPT FOR THE REPRESENTATIONS AND WARRANTIES SET FORTH IN THE PURCHASE AGREEMENT.

8. Assignment. This IP Assignment may be assigned in accordance with the provisions of the Purchase Agreement, including Section 10.06 thereof.

9. Binding Effect. This IP Assignment shall be binding upon and inure solely to the benefit of the parties hereto and their permitted successors and assigns and nothing herein, express or implied, is intended to or shall confer upon any other person or entity, any legal or equitable right, benefit or remedy of any nature whatsoever under or by reason of this IP Assignment.

10. No Amendment. This IP Assignment may not be amended, modified or supplemented except by an instrument in writing signed by, or on behalf of, the parties hereto.

11. Governing Law. This IP Assignment shall be governed by, and construed in accordance with, the Laws of the State of Delaware applicable to contracts executed in and to be performed in that state without giving effect to any choice or conflict of law provision or rule that would cause the application of the Law of any jurisdiction other than the State of Delaware.

12. Severability. If any provision of this IP Assignment shall be deemed invalid or unenforceable by any court of competent jurisdiction, then such portion shall be deemed severed, and the remainder thereof shall be enforceable in accordance with its terms.

13. Defined Terms. All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Purchase Agreement and the rules of construction set forth in Section 10.10 of the Purchase Agreement shall apply to this IP Assignment.

14. Counterparts; Execution by Electronic Means. This IP Assignment may be executed in several counterparts, each of which shall be deemed an original and all of which shall together constitute one (1) and the same instrument. The reproduction of signatures by means of facsimile device or other electronic means shall be treated as though such reproductions are executed originals.
