NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor does hereby grant to the Agent for the benefit of the Secured Parties a continuing security interest in the Trademarks to secure the prompt payment, performance and observance of the Secured Obligations.


