RELEASE OF SECURITY INTEREST IN TRADEMARKS/COPYRIGHTS

Releasor further agrees to execute and deliver to Releasee any and all further documents or instruments and do any and all further acts which Releasee (or Releasee's agents or designees) reasonably request in order to confirm this release and Releasee's right, title and interest in and to the Trademarks.
