Pursuant to Section 251 of the General Corporation Law of the State of Delaware (the "DGCL"), Boomi, Inc., a Delaware corporation ("Boomi"), hereby certifies to the following facts relating to the merger of UNIFI Software, Inc., a Delaware corporation ("UNIFI"), with and into the Boomi (the "Merger"):

**FIRST:** The name and state of incorporation of each constituent corporation that is a party to the Merger are as follows:

Boomi, Inc.	Delaware

**SECOND:** An Agreement and Plan of Merger, dated as of March 30, 2020 (the "Merger Agreement"), by and between Boomi and UNIFI has been approved, adopted, executed and acknowledged by each of the constituent corporations in accordance with Section 251 of the DGCL (and by the written consent of the sole stockholder of each of the constituent corporations in accordance with Section 228 of the DGCL).

**THIRD:** The name of the corporation surviving the Merger (the "Surviving Corporation") is Boomi, Inc., a Delaware corporation.

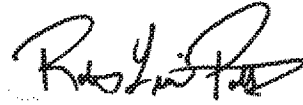
**FOURTH:** The certificate of incorporation of Boomi as in effect immediately prior to the Merger shall be the certificate of incorporation of the Surviving Corporation.
