**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of September 29, 2021, is made by ALTER DOMUS (US) LLC, a Delaware limited liability company, as Administrative Agent and Collateral Agent (in such capacity, the "Successor Agent" or the "Secured Party"), in favor of Premiere Fibers, LLC, a Delaware limited liability company. Capitalized terms used but not otherwise defined herein shall have the meaning assigned to them in the Credit Agreement (as defined below).

**W I T N E S S E T H**

WHEREAS, reference is hereby made to that certain First Lien Credit Agreement, dated as of October 2, 2015, as amended by that certain First Amendment to First Lien Credit Agreement, dated as of October 19, 2016, Second Amendment to First Lien Credit Agreement, dated as of May 23, 2017, Third Amendment to First Lien Credit Agreement, dated as of March 20, 2019, Limited Wavier and Fourth Amendment to First Lien Credit Agreement, dated as of July 13, 2020, Waiver and Fifth Amendment to First Lien Credit Agreement, dated as of October 2, 2020, First Lien Waiver Extension and Amendment Letter dated as of April 1, 2021, Second Limited Waiver to First Lien Credit Agreement, dated as of May 4, 2021, Sixth Amendment, Resignation, Waiver, Consent and Appointment Agreement, dated as of May 4, 2021 (the "Sixth Amendment"), and Third Limited Waiver and Seventh Amendment to First Lien Credit Agreement, dated as of June 8, 2021, and as may be further amended, restated, supplemented, restructured, refinanced, or otherwise modified from time to time (the "Credit Agreement"), among Borrower, each Lender party thereto from time to time, the Guarantors, and the Successor Agent;

WHEREAS, in accordance with the Credit Agreement, PREMIERE FIBERS, INC. (the "Grantor") granted to BNP PARIBAS, as the initial Administrative Agent and initial Collateral Agent under the Credit Agreement (in such capacity, the "Initial Agent"), for the benefit of the Secured Parties a security interest in all right, title or interest in, to or under any and all of the Trademark Collateral (as defined in the Trademark Security Agreement) pursuant to that certain Grant of Security Interest in Trademarks, dated October 2, 2015, by the Grantor in favor of the Initial Agent, recorded at the United States Patent and Trademark Office at Reel/Frame 5636/0429 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Sixth Amendment, the Initial Agent resigned as the Administrative Agent and Collateral Agent under the Credit Agreement and other Loan Documents, and the Successor Agent assumed and succeeded to all of the rights, powers, duties and obligations of the Administrative Agent and Collateral Agent under the Credit Agreement;

WHEREAS, pursuant to that certain Assignment of Trademark Security Agreement, dated June 3, 2021, by the Initial Agent in favor of the Successor Agent, recorded at the United States Patent and Trademark Office at Reel/Frame 7319/0371, the Initial Agent transferred, assigned, granted and conveyed to the Successor Agent, for the ratable benefit of the

Lenders and Secured Parties, all of the Initial Agent's security interest in all right, title or interest in, to or under any and all of the Trademark Collateral; and

WHEREAS, the Grantor converted to and is continuing as a Delaware limited liability with the name "PREMIER FIBERS, LLC".

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby TERMINATES, without recourse, representation or warranty of any kind or nature the Trademark Security Agreement, and RELEASES, without recourse, representation or warranty of any kind or nature its security interest in all of the Trademark Collateral, including the trademark registrations set forth in Schedule A attached hereto and incorporated herein by reference.
