Release of Security Interest in Trademarks

WHEREAS, the First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 2, 2021 at Reel/Frame 7177/0052; and

WHEREAS, the Administrative Agent desires to release, terminate, discharge and relinquish the security interest and lien in the Trademarks set forth on Schedule I attached hereto.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent on behalf of itself and the secured parties, hereby releases, terminates, discharges and relinquishes unto the Pledgor the continuing security interest in, and lien on, the Trademarks set forth on Schedule I attached hereto and otherwise assigns, grants and conveys to the Pledgor, without recourse, any and all right, title and interest the Administrative Agent or the secured parties may have in, to or under to the Trademarks set forth on Schedule I attached hereto in order to revert in the Pledgor full and unencumbered title to said Trademarks set forth on Schedule I attached hereto.

The Pledgor, or any successor to the Pledgor (including any person or entity hereafter having any right, title or interest in or to the Trademarks set forth on Schedule I attached hereto), is hereby authorized to record this Release in the United States Patent and Trademark Office.


