TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the “**Assignment**”) is between Ecolab USA Inc. WHEREAS, Assignee desires to acquire any and all rights and goodwill associated with the Mark and the above-referenced registration owned by Assignor;

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and related agreements and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor does hereby assign to Assignee effective as of the Effective Date all right, title, and interest in and to the Mark and the registration thereof, together with the goodwill associated with or symbolized by the Mark.
2. Assignor hereby authorizes the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee. Following the Effective Date, Assignor shall take such steps and actions, and provide such reasonable cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Mark to Assignee.
3. This Assignment may be executed by the parties hereto in several counterparts and each such counterpart will be deemed an original, but all such counterparts will together constitute one and the same agreement. Execution of a facsimile or scanned copy will have the same force and effect as execution of an original, and a facsimile signature will be deemed an original and valid signature.
