## RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release"), dated as of 1st day of October, 2021, is made by Regions Bank, as Administrative Agent, having a place of business at 1180 West Peachtree Street NW, Suite 1000, Atlanta, GA 30309, ("Administrative Agent") in favor of Nutravail Products, LLC, a Delaware Limited Liability Company, having a place of business at 300 Crescent Court, Suite 550 Dallas, Texas 75201 ("Nutravail")

WHEREAS, Nutravail and Administrative Agent are parties to a Notice of Grant of Security Interest in U.S. Trademarks dated as of April 3, 2017 recorded with the United States Patent and Trademark Office on November 18, 2020 at Reel 7104, Frame 0672 (the "Notice");

WHEREAS, pursuant to the Notice, Nutravail granted to Administrative Agent, a security interest in Nutravail's right, title and interest in and to those U.S. Trademark Registrations and Applications referred to on Schedule A hereto ("Intellectual Property Collateral").

WHEREAS, Administrative Agent has agreed to terminate and release all of its right, title and interest in or to the Intellectual Property Collateral, including the Notice.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. Administrative Agent hereby terminates, extinguishes, cancels, releases and discharges any and all right, title and interest, including the Security Interest, in and to the Intellectual Property Collateral arising in connection with the Notice and assigns, discharges, quit claims and relinquishes unto Nutravail any and all right, title and interest it has in and to the Intellectual Property Collateral.


2. Further Assurances. Administrative Agent shall take all further actions, and provide to Nutravail and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by Nutravail, and at Nutravail's cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the New York, without regard to principles of conflicts of laws requiring application of the law of any other jurisdiction.
