DECLARATION OF LEO M. LOUGHLIN

I, Leo M. Loughlin, submit this Declaration and accompanying documents to the Assignment Branch to correct the title for Registration No. 2,377,290. I declare that I have first-hand knowledge of the facts below:

- 1) On June 17, 2016, AWI Licensing Company recorded a Change of Name document at Reel/Frame 5816/0838 changing its entity name to AWI Licensing LLC, for seventy-nine (79) trademark properties.
- 2) Among these properties, U.S. Reg. No. 2,377,290 for the mark DELIFOL was included. Attached is the Change of Name Documentation, the previous Cover Sheet and the Change of Name Recordation (*marked-up to show the wrongly recorded property*) for your convenience.
- 3) Registration No. 2,377,290 *was included in error* in the above recordation because it was never owned by AWI Licensing Company or assigned to AWI Licensing Company. Therefore, the recordal was made in error.


It is respectfully requested that this recordal be removed from the chain of title and to restore title back to the name of:

Armstrong DLW Licensing GmbH

The undersigned and current attorney of record was in contact with the previous counsel who made the error and previous counsel agreed to try to correct their error. However, previous counsel has been unsuccessful in their attempts to make the correction.

The current Registrant is facing a deadline of November 21, 2021 to respond to an Office Action. The Office Action issued because of a break in the chain of title. If the chain of title is not resolved, the registration may be cancelled by operation of law. Additionally, further assignment documents need to be recorded to the current owner before the above due date.

I declare that, to the best of my knowledge and belief, the information herein is true and complete. I understand this statement is made for use as evidence in court and is subject to penalty for perjury.
