## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**, dated as of October 1, 2021 (this “Release”), is made by CITIZENS BANK, N.A., as Collateral Agent for the Secured Parties (the “Collateral Agent”) in favor of UTGR, INC., a Delaware corporation, PREMIER ENTERTAINMENT BILOXI LLC, a Delaware limited liability company, and PREMIER ENTERTAINMENT III, LLC, a Delaware limited liability company (the “Grantors”). Capitalized terms used but not defined herein having the meanings assigned to them in the Credit Agreement.

### WITNESSETH

WHEREAS, Grantors, Collateral Agent, and the other parties party thereto from time to time, are parties to that certain Credit Agreement dated as of May 10, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) and Security Agreement dated as of May 10, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantors executed the Confirmatory Grant of Security Interest in United States Intellectual Property, dated as of May 10, 2019 (the “Intellectual Property Security Agreement”) and recorded with the U.S. Patent and Trademark Office on May 10, 2019 at Reel/Frame Nos. 6643/0318, 6643/0298, and 6643/0308, pursuant to which the Grantors granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in all of Grantors’ right, title and interest in and to the Trademarks (as defined in the Intellectual Property Security Agreement), together with all proceeds of such Trademarks, the goodwill associated with such Trademarks and all causes of action arising for infringement of such Trademarks or unfair competition regarding the same.

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in all right, title and interest in, to and under the Trademarks.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademarks, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademarks is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademarks under the Security Agreement and the Intellectual Property Security Agreement.


