## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "**Agreement**") sets forth the agreement by and between Miriam R. Stein, not individually, but solely in her capacity as Chapter 7 Trustee of the bankruptcy estate of Johnson Publishing Company, LLC, a Delaware limited liability company ("**Assignor**") and FFAIR ACQUISITION, LLC, a Delaware limited liability company ("**Assignee**") with respect to the Acquired Rights (as defined below), and is dated as of December 5, 2019.

1. Assignment. In consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably sells, assigns, transfers, conveys, and quitclaims to Assignee, and its successors and assigns, and Assignee hereby accepts, all of Assignor's right, title, and interest of every kind and nature, worldwide, that may be obtained under the laws now or hereafter in effect in the United States or any other country, in and to the Fashion Fair Trademarks, as defined in the Asset Purchase Agreement between the Parties dated October 28, 2019 ("**Acquired Rights**" and such agreement the "**Asset Purchase Agreement**"). The Acquired Rights include any and all of Assignor's right, title in, to and under:

- (a) the trademarks scheduled on Exhibit A attached hereto (the "**Fashion Fair Trademarks**") together with that portion of Assignor's business connected with the use of and symbolized by the Fashion Fair Trademarks, and all past and present goodwill associated therewith or symbolized thereby;
- (b) all common law rights thereto;
- (c) issuances, extensions, and renewals of any registrations and applications related thereto;
- (d) claims, demands and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, breach, or default; and
- (e) other rights, privileges, and protections of any kind whatsoever of Assignor accruing under any of the foregoing provided at law or in equity throughout the world, including the right to all income, royalties, damages and payments hereafter due or payable with respect to the Fashion Fair Trademarks and the right to register, prosecute, maintain and defend the Fashion Fair Trademarks before any public or private agency, office or registrar.

Assignor hereby waives any moral rights that Assignor may have in the Acquired Rights. No rights are reserved by the Assignor. The parties acknowledge and agree that Assignor is selling, assigning, transferring, and conveying whatever interest Assignor has or may have in the Acquired Rights, if any, without any representations or warranties of any kind. Assignor hereby authorizes the Commissioner of Patents and Trademarks in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational

authorities, to record Assignee as the assignee of all of Assignor's right, title and interest in, to and under the Fashion Fair Trademarks and to deliver to Assignee, and to Assignee's attorneys, agents, successors or assigns, all official documents and communications.

2. Consideration. As consideration in full for the Acquired Rights, Assignee shall pay Assignor the amount specified in the Asset Purchase Agreement.

3. Further Assurances. From and after the date hereof, and subject to the terms of the Asset Purchase Agreement (including, without limitation, Section 2.6 thereof), upon Assignee's reasonable request, and at Assignee's expense, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to carry out the provisions hereof and give effect to the transactions contemplated by this Agreement, to the extent such requested actions would not in the Assignor's sole discretion violate any applicable law.

4. General.

(a) Entire Agreement. This Agreement and the Asset Purchase Agreement to which it is attached constitute the sole and entire agreement of the parties with respect to the subject matter contained herein, and supersede all prior and contemporaneous understandings and agreements, both written and oral, with respect to such subject matter.

(b) Severability. If any term or provision of this Agreement is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction.

(c) Successors and Assigns. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

(d) Governing Law; Venue. All matters arising out of or relating to this Agreement shall be governed by and construed in accordance with the relevant laws of the United States, including federal copyright, trademark and patent laws, and with the laws of the State of Illinois applicable to contracts executed in and to be performed in that State, without regard to choice or conflict of law principles that would result in application of any other laws other than the laws of the State of Illinois. Any legal suit, action, or proceeding arising out of or relating to this Agreement or the transactions contemplated hereby shall be instituted in the (i) United States Bankruptcy Court for the Northern District of Illinois, Eastern Division, so long as the bankruptcy case of Johnson Publishing Company, LLC is pending (Case No. 19-10236) (the "**Bankruptcy Case**"), or (ii) any State or federal court in Cook County, Illinois after closure of the Bankruptcy Case, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such legal suit, action, or proceeding.

(e) Amendment and Modification. This Agreement may only be amended, modified, or supplemented by an agreement in writing signed by each party hereto.

(f) Waiver. No waiver by any party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the party so waiving. Except as otherwise set forth in this Agreement, no failure to exercise, or delay in exercising, any right, remedy, power, or privilege arising from this Agreement shall operate or be construed as a waiver thereof; and any single or partial exercise of any right, remedy, power, or privilege hereunder shall not preclude any other or further exercise thereof or the exercise of any other right, remedy, power, or privilege.

(g) Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Agreement delivered by email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

(h) Asset Purchase Agreement. This Agreement is subject to the terms of the Asset Purchase Agreement which shall control in the event of any conflict between the terms thereof and this Agreement. Capitalized terms not defined herein shall have the meanings set forth in the Asset Purchase Agreement.

THE PARTIES HEREBY IRREVOCABLY WAIVE ALL RIGHTS TO TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM (WHETHER BASED IN CONTRACT, TORT OR OTHERWISE) ARISING OUT OF OR RELATING TO THIS AGREEMENT OR THE ACTIONS OF ASSIGNOR, ASSIGNEE, OR THEIR RESPECTIVE REPRESENTATIVES IN THE NEGOTIATION OR PERFORMANCE HEREOF.
