**RELEASE OF SECURITY INTEREST
(TRADEMARKS)**

This RELEASE OF SECURITY INTEREST (TRADEMARKS) (this “**Release**”), dated as of October 1, 2021, is made by Golub Capital Markets LLC, as Collateral Agent (“**Collateral Agent**”) from time to time a party to the Credit Agreement (as defined below).

WHEREAS, pursuant to that certain Credit Agreement dated as of May 31, 2019 (the “**Credit Agreement**”) by and among the Collateral Agent and Appriss Holdings, Inc., a Delaware corporation (“**Borrower**”), Alert Intermediate Holdings II, Inc., a Delaware corporation (“**Holdings**”), the several Lenders from time to time party thereto (the “**Lenders**”) and the various other parties thereto (as amended by that certain First Amendment to Credit Agreement, dated as of July 9, 2019, by that certain Second Amendment to Credit Agreement, dated as of October 14, 2020 and by that certain Third Amendment, dated as of March 23, 2021 and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof), the Lenders agreed to make a loan facility available to Borrower.

WHEREAS, the Borrower, Holdings and certain Subsidiaries of the Borrower are party to that certain Security Agreement dated of even date with the Credit Agreement (as supplemented by that certain Supplement, dated as of July 9, 2019 and by that certain Supplement, dated as of November 23, 2020 and as amended, restated, amended and restated, supplemented, waived or otherwise modified from time to time, the “**Security Agreement**”) in favor of the Collateral Agent.

WHEREAS, pursuant to the Security Agreement, Grantors executed in favor of the Collateral Agent (i) that certain Trademark Security Agreement, dated as of May 31, 2019 (the “**Initial Trademark Security Agreement**”), between the Collateral Agent and Appriss Inc, a Delaware Corporation (“**Appriss**”), HD Information, LLC, a Delaware limited liability company (“**HD**”) and The Retail Equation, Inc., a Delaware corporation (“**Equation**”), recorded at the United States Patent and Trademark Office on May 31, 2019, at Trademark Reel 6658, Frame 0864, (ii) that certain Trademark Security Agreement, dated as of July 9, 2019 (the “**Innovative Trademark Security Agreement**”), between the Collateral Agent and Innovative Enterprises, Inc., a Virginia corporation (“**Innovative**”), recorded at the United States Patent and Trademark Office on July 9, 2019, at Trademark Reel 6689, Frame 0292, (iii) that certain Trademark Security Agreement, dated as of August 15, 2019 (the “**ARI Trademark Security Agreement**”), between the Collateral Agent and Appriss Retail Information, LLC, a Delaware limited liability company (“**ARI**”), recorded at the United States Patent and Trademark Office on August 15, 2019, at Trademark Reel 6721, Frame 0577 and (iv) that certain Trademark Security Agreement, dated as of November 23, 2020 (the “**Securitec Trademark Security Agreement**” and, together with the Initial Trademark Security Agreement, the Innovative Trademark Security Agreement and the ARI Trademark Security Agreements, the “**Trademark Security Agreement**”), between the Collateral Agent and Securitec Scening Solutions, Inc., a Virginia corporation (“**Securitec**” and, together with Appriss, Equation, Innovative and ARI, the “**Grantors**”), wherein the Grantors granted to the Collateral Agent a security interest in all of the Grantors’ rights, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreements), including without limitation the intellectual property set forth on Schedule 1 attached hereto (collectively, the “**Collateral**”);

WHEREAS, Collateral Agent has agreed to terminate and release its security interest in all such Collateral, as provided in the Trademark Security Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent hereby relinquishes, terminates, cancels and releases any and all right, title and interest it may have or have acquired in the Collateral through the Trademark Security

Agreements, including all rights of any kind whatsoever of Grantors accruing under the Collateral provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world; any and all patents, trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedule I hereto, together with all extensions and renewals thereof and amendments thereto; any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages. Collateral Agent hereby authorizes and requests that this Release be recorded at the United States Patent and Trademark Office, or any other applicable location. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Trademark Security Agreements, and if not set forth therein, the Credit Agreement.
