TERMINATION AND RELEASE OF SECURITY INTEREST

August 17

This **TERMINATION AND RELEASE OF SECURITY INTEREST**, dated as of July 20, 2021 ("Release"), is made by **PLEXUS FUND V-A, L.P.**, as administrative agent, a Delaware Limited Partnership ("Secured Party"), in favor of **ROUND 2, LLC**, an Indiana Limited Liability Company ("Debtor").

WHEREAS, pursuant to that certain Security Agreement dated as of January 12, 2021 ("Security Agreement") by and among the Debtors and Secured Party, Debtors granted to the Secured Party a continuing security interest in the property listed on Schedule A attached hereto (the "Collateral"); and

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on January 12, 2021 at Reel 7202/ Frame 0461.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Secured Party and Debtor agree as follows:

SECTION 1. Termination and Release. Secured Party hereby:


- (a) terminates the Security Agreement with respect to the Collateral;
- (b) terminates, cancels, forever discharges, and releases the first continuing security interest in Collateral, including in the property listed on Schedule A attached hereto and releases any and all other claims it may have in the Collateral;
- (c) represents and warrants that it has full authority to execute and deliver this Release; and
- (d) authorizes the recordation of this Release with the USPTO at Debtor's expense.

SECTION 3. Further Assurances. Secured Party, at Debtor's expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Collateral, Secured Party will, at Debtor's expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Secured Party has caused this Termination and Release of Security Interest to be duly executed as of the date first set forth above.
