This Assignment Agreement is made by and between:

The Assignor incorporates by reference its ownership rights, representations, and warranties set forth in the Asset Purchase Agreement by and between Saltire Brands, LLC, James Hunter, individually, and Handyman Pro, LLC with respect to the Trademarks, subject to all conditions, limitations, limitations on liability and restrictions as set forth therein.
