RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (“Release”) is made as of this 27th day of September 2021, by Guggenheim Credit Services, LLC, in its capacity as administrative agent and collateral agent (the “Security Agent”) for the Secured Parties (as defined in that certain Pledge and Security Agreement dated as of April 4, 2013), in favor of Educate Digital, LLC (the “Grantor”).

WHEREAS, pursuant to the Grant of Security Interest in Trademarks, dated as of June 11, 2019 (the “Security Agreement”), a security interest was granted by the Grantor to the Security Agent in the Trademarks (as defined in the Security Agreement), including the United States trademarks set forth in Schedule A hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 21, 2019 at Reel/Frame 6675/0645;

WHEREAS, the Security Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in all Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Security Agent hereby states as follows:

1. Release of Security Interest. The Security Agent, on its and the Secured Parties’ behalf, hereby terminates the Security Agreement and absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges the collateral pledges, grants, liens and security interests granted by the Grantor in favor of the Security Agent (on behalf of itself, the Secured Parties and their permitted successors and assigns) in and to the Trademarks and all rights, title and interests in, to and under the Trademarks.

3. Recordation of Release. The Security Agent understands and agrees that this Release may be recorded by the Grantor, or its successors or assigns, with the United States Patent and Trademark Office.

4. Governing Law. This Release shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, excluding conflict of laws principles that would cause the application of laws of any other jurisdiction.
