**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK  
RIGHTS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of August 17, 2021 (this "Release") is made by GREENSILL CAPITAL (UK) LIMITED (IN ADMINISTRATION) (together with its successors and permitted assigns, the "Secured Party") acting by one of its joint administrators Christine Mary Laverty, Trevor Patrick O'Sullivan and William George Edward Stagg each a licensed insolvency practitioner of Grant Thornton UK LLP of 30 Finsbury Square, Finsbury, London EC2A 1AG (the Administrators) under that certain Trademark Security Agreement, dated as of June 25, 2020 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Agreement") between EQUIPMENTSHARE.COM INC, a Delaware corporation (the "Company") and the Secured Party. Capitalized terms used but not defined herein have the meanings provided in the Agreement.

WHEREAS, pursuant to the Agreement, the Company granted to the Secured Party a continuing security interest in all of Company's right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral, including those set forth on the attached **Schedule A**;

WHEREAS, the Company has requested and the Secured Party has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby absolutely, unconditionally and irrevocably, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Secured Party in the Released Collateral, and (d) reassigns, grants and conveys to the Company any and all right, title and interest it has in the Released Collateral.

The Administrators act as agents for and on behalf of the Secured Party and neither they nor their firm, partners, employees, representatives or agents shall incur any personal liability whatsoever in respect of any of the obligations undertaken by the Secured Party, or in respect of any failure on the part of the Secured Party to observe, perform or comply with any such obligations made pursuant to or in connection with this agreement. Nothing in this agreement shall give rise to any debt, liability or claim that is payable as an expense of the administration of the Secured Party.
