DEED OF ASSENT TO THE INDUSTRIAL PROPERTY RIGHTS PLEDGE RELEASE

DEUTSCHE BANK AG, LONDON BRANCH, branch office validly constituted and in force under the laws of England and Wales, with registration number 338230 and headquartered at Winchester House, 1 Great Winchester Street, London EC2N 2DB, United Kingdom, in the person of its authorized representatives indicated below in the appropriate signature spaces, which company acts in the subscription of this deed of assent to the industrial property rights pledge release (hereinafter the "**Deed of Release**") by virtue of the mandate to act as Collateral Agent assigned to it pursuant to the provisions of Art. 10.01 (c) of the Indenture as defined below (the "**Collateral Agent**").

WHEREAS:

- (A) On December 13, 2010, the company Mark IV Europe Lux S.C.A., in its capacity as "European Group Issuer" (the "**European Group Issuer**") and Mark IV USA LuX S.C.A., in its capacity as "U.S. Group Issuer" (the "U.S. Group Issuer", and, together with the European Group Issuer, the "**Issuers**"), issued debt securities called senior secured notes (the "**Bonds**"), at an interest rate of 8.875%, for a total capital amount of Euro 200,000,000.00, maturing in 2017 (the "**Bond Loan**"), the characteristics of which are regulated pursuant to a deed called the "Indenture", signed on December 13, 2010 by the Issuers, by the Deutsche Trustee Company Limited as the Trustee and by the Collateral Agent and related guarantors, governed by the laws of the State of New York (the "**Indenture**").
- (B) Pursuant to Art. 10.1(c) of the Indenture, Deutsche Bank AG, London Branch, was appointed "Collateral Agent" in relation to the Bond Loan and in its related contracts.
- (C) In order to guarantee its obligations within the limits established by Section 11.02 of the Indenture, on December 13, 2010, Dayco Europe S.r.l., as European Group Guarantor, signed an agreement for the constitution of a pledge on industrial property rights called "Constitution of Pledge on Industrial Property Rights of Dayco Europe S.r.l." (the "**Pledge Deed**") authenticated in the signatures by Dr. Richard John Saville, Notary in London, filed with Dr. Caterina Bima, Notary in Turin on January 13, 2011, index no. 114836, folder no. 27317, recorded in Turin on January 14, 2011 at number 1078, pursuant to which Dayco Europe S.r.l., a single shareholder company constituted in Italy, with registered office in Chieti (CH), Via papa Leone XIII, 45, share capital Euro 84,000,000.00 (eighty four million/00), fully paid, tax ID and Chieti Business Registry Number 00703890673 (the "**Constituent**") has pledged, jointly and pro-indiviso in favor of the Guaranteed Parties (as defined in the Pledge Deed) and in guarantee of the Guaranteed Credits (also as defined therein), some company trademarks and patents for industrial inventions defined therein as "**Industrial Property Rights**" and

better indicated in Annex B - List of Industrial Property Rights - of the Pledge Deed (the "**Pledge**").

ALL THIS BEING SAID, and as the foregoing forms an integral and substantial part of this Deed of Release;

with this Deed of Release the Collateral Agent

DECLARES

that following the fulfillment of the obligations provided for by the Indenture and of the release of the underlying obligations, in compliance with the provisions of Art. 10.05(a)(1) of the Indenture, to acknowledge that their rights of guarantee deriving from the Pledge Deed are automatically and unconditionally extinguished and, consequently, to consent to the unconditional and complete cancellation and release of the guarantee rights established on the Industrial Property Rights pursuant to the Pledge.

In particular, the Collateral Agent authorizes the constituent:

(i) to have this Pledge Release Deed transcribed, as appropriate and within their respective competence, at (a) the Italian Trademark and Patent Office, based on articles 138 et seq. and 195 et seq. of Legislative Decree February 10, 2005, no. 30, (b) at the Community Office for the Harmonization of the Internal Market (OHIM - Alicante, Spain); (c) the European Patent Office (Munich - Germany) and (d) the competent United States Patent and Trademark Office (United States Patent and Trademark Office, USPTO - Washington D.C., USA);

(ii) to carry out any other formalities necessary to implement this Pledge Release Deed.

The taxes, duties and expenses of this Deed of Release, of the consequent obligations, registrations and transcriptions are borne by the Constituent.

This deed is subject to a fixed registration tax (Euro 168.00).

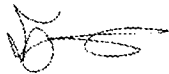

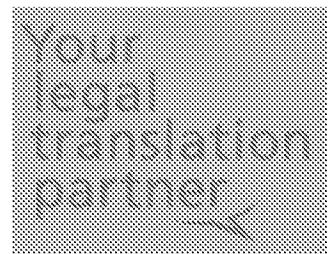

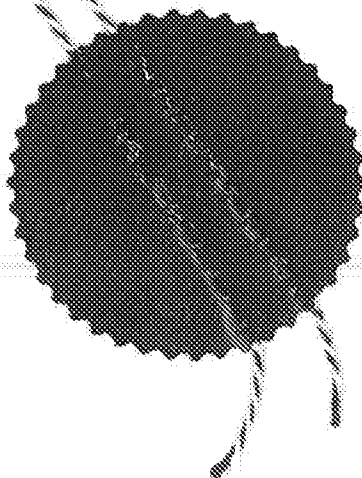

DI PROPRIETÀ INDUSTRIALE**

DEUTSCHE BANK AG, LONDON BRANCH, *branch office* validamente costituito e vigente ai sensi della legge dell'Inghilterra e del Galles, con numero di iscrizione 338230 e con sede in Winchester House, 1 Great Winchester Street, Londra EC2N 2DB, Regno Unito, in persona dei propri rappresentanti autorizzati di seguito indicati negli appositi spazi di firma, la quale società interviene alla sottoscrizione del presente atto di assenso alla cancellazione di pegno su diritti di proprietà industriale (di seguito l' "Atto di Rilascio") in virtù del mandato ad agire in qualità di *Collateral Agent* conferitole in forza di quanto previsto dall'Art. 10.01 (c) dell' *Indenture* come *infra* definito (il "*Collateral Agent*").

PREMESSO CHE:

d'impresa e brevetti per invenzioni industriali ivi definiti quali "Titoli di Proprietà Industriale" e meglio indicati nell'Allegato B - Elenco dei Titoli di Proprietà Industriale - dell'Atto di Pegno (il "Pegno").
