## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “*Release*”) is made and effective as of October 4, 2021 (the “*Effective Date*”) and granted by GOLDMAN SACHS SPECIALTY LENDING GROUP, L.P., as collateral agent (“*Agent*”), for the ratable benefit of the Lenders (defined below), in favor of Agilon Software LLC, a Delaware limited liability company, Event Rental Systems Software LLC, a Delaware limited liability company, Euclid Technology Solutions, LLC, a Delaware limited liability company, Diamond Data Systems, Inc., a Texas corporation, Association Consulting Group, Inc., a Maryland corporation, EZClaim Software LLC, a Delaware limited liability company, StarChapter Software LLC, a Delaware limited liability company, Space Control Software LLC, a Delaware limited liability company, Clip SW LLC, a Delaware limited liability company, Print Reach Software LLC, a Delaware limited liability company, Adventure Office Software LLC, a Delaware limited liability company, Unified Practice, Inc., a Delaware corporation, Winworks Software LLC, a Delaware limited liability company, XOLogic Software LLC, a Delaware limited liability company, Total Party Planner Software LLC, a Delaware limited liability company, Aisle Planner Inc., a Delaware corporation, ISI Software LLC, a Delaware limited liability company, Enrollware Software LLC, a Delaware limited liability company, netPark Software LLC, a Delaware limited liability company, and SalonRunner Software LLC, a Delaware limited liability company (each a “*Grantor*” and, collectively, the “*Grantors*”); and has reference to the following facts and circumstances (the “*Recitals*”):

A. The Grantors, Agent and the Lenders are party to that certain Credit and Guaranty Agreement, dated as of May 23, 2019 (as it may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*Credit Agreement*”).

B. As described in the Trademark Security Agreement dated as of May 23, 2019, executed by Agilon Software LLC, Event Rental Systems Software LLC, and Euclid Technology Solutions, LLC in favor of the Agent (the “*AEE Security Agreement*”), Agilon Software LLC, Event Rental Systems Software LLC, and Euclid Technology Solutions, LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the AEE Security Agreement). The AEE Security Agreement was recorded with the United States Patent and Trademark Office on May 28, 2019, at Reel/Frame 6654/0321.

C. As described in the Trademark Security Agreement dated as of August 16, 2019, executed by Enrollware Software LLC, netPark Software LLC and SalonRunner Software LLC in favor of the Agent (the “*ENS Security Agreement*”), Enrollware Software LLC, netPark Software LLC and SalonRunner Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the ENS Security Agreement). The ENS Security Agreement was recorded with the United States Patent and Trademark Office on August 18, 2019, at Reel/Frame 6722/0971.

D. As described in the Trademark Security Agreement dated as of May 14, 2020, executed by Diamond Data Systems, Inc. in favor of the Agent (the “*Diamond Security Agreement*”), Diamond Data Systems, Inc. granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Diamond Security Agreement). The Diamond Security Agreement was recorded with the United States Patent and Trademark Office on May 15, 2020, at Reel/Frame 6939/0973.

E. As described in the Trademark Security Agreement dated as of May 26, 2020, executed by Association Consulting Group, Inc. in favor of the Agent (the “*ACGI Security Agreement*”), Association Consulting Group, Inc. granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the ACGI Security Agreement). The ACGI Security Agreement was recorded with the United States Patent and Trademark Office on May 28, 2020, at Reel/Frame 6948/0167.

F. As described in the Trademark Security Agreement dated as of July 1, 2020, executed by EZClaim Software LLC in favor of the Agent (the “*EZClaim Security Agreement*”), EZClaim Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the EZClaim Security Agreement). The EZClaim Security Agreement was recorded with the United States Patent and Trademark Office on July 2, 2020, at Reel/Frame 6989/0116.

G. As described in the Trademark Security Agreement dated as of July 21, 2020, executed by StarChapter Software LLC in favor of the Agent (the “*StarChapter Security Agreement*”), StarChapter Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the StarChapter Security Agreement). The StarChapter Security Agreement was recorded with the United States Patent and Trademark Office on July 22, 2020, at Reel/Frame 7005/0256.

H. As described in the Trademark Security Agreement dated as of August 14, 2020, executed by Space Control Software LLC in favor of the Agent (the “*SC Security Agreement*”), Space Control Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark

Collateral (as defined in the SC Security Agreement). The SC Security Agreement was recorded with the United States Patent and Trademark Office on August 14, 2020, at Reel/Frame 7024/0584.

I. As described in the Trademark Security Agreement dated as of November 3, 2020, executed by Clip SW LLC in favor of the Agent (the "**Clip Security Agreement**"), Clip SW LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Clip Security Agreement). The Clip Security Agreement was recorded with the United States Patent and Trademark Office on November 13, 2020, at Reel/Frame 7105/0270.

J. As described in the Trademark Security Agreement dated as of December 15, 2020, executed by ISI Software LLC in favor of the Agent (the "**ISI Security Agreement**"), ISI Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the ISI Security Agreement). The ISI Security Agreement was recorded with the United States Patent and Trademark Office on December 16, 2020, at Reel/Frame 7194/0667.

K. As described in the Trademark Security Agreement dated as of January 4, 2021, executed by Print Reach Software LLC in favor of the Agent (the "**PR Security Agreement**"), Print Reach Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the PR Security Agreement). The PR Security Agreement was recorded with the United States Patent and Trademark Office on January 5, 2021, at Reel/Frame 7144/0299.

L. As described in the Trademark Security Agreement dated as of January 8, 2021, executed by Adventure Office Software LLC in favor of the Agent (the "**AO Security Agreement**"), Adventure Office Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the AO Security Agreement). The AO Security Agreement was recorded with the United States Patent and Trademark Office on January 11, 2021, at Reel/Frame 7159/0568.

M. As described in the Trademark Security Agreement dated as of May 26, 2021, executed by Unified Practice, Inc. in favor of the Agent (the "**UP Security Agreement**"), Unified Practice, Inc. granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the UP Security Agreement). The UP Security Agreement was recorded with the United States Patent and Trademark Office on May 27, 2021, at Reel/Frame 7308/0085.

N. As described in the Trademark Security Agreement dated as of July 15, 2021, executed by Winworks Software LLC in favor of the Agent (the "**Winworks Security Agreement**"), Winworks Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Winworks Security Agreement).

O. As described in the Trademark Security Agreement dated as of July 15, 2021, executed by XOLogic Software LLC in favor of the Agent (the "**XO Security Agreement**"), XOLogic Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the XO Security Agreement).

P. As described in the Trademark Security Agreement dated as of August 25, 2021, executed by Total Party Planner Software LLC in favor of the Agent (the "**TPP Security Agreement**"), Total Party Planner Software LLC granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the TPP Security Agreement). The TPP Security Agreement was recorded with the United States Patent and Trademark Office on September 21, 2021, at Reel/Frame 7427/0234.

Q. As described in the Trademark Security Agreement dated as of September 14, 2021, executed by Aisle Planner Inc. in favor of the Agent (the "**AP Security Agreement**" and, together with the AEE Security Agreement, the ENS Security Agreement, the Diamond Security Agreement, the ACGI Security Agreement, the EZClaim Security Agreement, the StarChapter Security Agreement, the SC Security Agreement, the Clip Security Agreement, the ISI Security Agreement, the PR Security Agreement, the AO Security Agreement, the UP Security Agreement, the Winworks Security Agreement, the XO Security Agreement and the TPP Security Agreement, each individually a "**Security Agreement**" and, collectively, the "**Security Agreements**"), Aisle Planner Inc. granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the AP Security Agreement).

R. The Grantors requested that Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to each Grantor of any and all right, title and interest Agent, on behalf of itself and Lenders, may have in the Trademark Collateral (as defined in the Security Agreements, as applicable) pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, Agent states as follows:

1. Recitals. The Recitals are true and correct, and, together with the defined terms set forth herein, are incorporated by this reference.

2. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreements and Credit Agreement, as applicable.

3. Release of Security Interest. Agent, on behalf of itself and Lenders, terminates each Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to each Security Agreement in any and all of each Grantor's right, title and interest in, to and under the Trademark Collateral, and reassigns to each Grantor any and all right, title and interest that it may have, in, to and under the Trademark Collateral, including certain trademarks described in Exhibit A.

4. Further Assurances. Agent agrees, at the Grantors' expense, to take all further actions, and provide to each Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

5. Governing Law. The validity and interpretation of this Release and the rights and obligations of Lender shall be governed by and construed in accordance with the substantive laws of the State of New York (without reference to conflict of law principles).

Agent executed this Release in favor of the Grantors as of the Effective Date.


