## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of September 17, 2021 (the “Effective Date”), is made by Wells Fargo Bank, National Association, in its capacity as Agent and L/C Issuer (the “Agent”), in favor of the grantor party identified on the signature page hereto (the “Grantor”).

WHEREAS, Grantor is the owner of certain Trademarks previously owned by Eurostar Brands, Inc. (“Eurostar Brands”) by operation of law and various written transfers including, but not limited to, a Nunc Pro Tunc Trademark Assignment effective January 1, 2014, and a Nunc Pro Tunc Trademark Assignment effective September 19, 2014;

WHEREAS, pursuant to that certain Security Agreement, dated as of November 26, 2014, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral, pursuant to which the Grantor granted a security interest in and to (i) all of the Grantor's and Eurostar Brands' right, title and interest in, to and under the Trademarks set forth on Schedule A attached hereto; (ii) all proceeds and products of the Trademarks; (iii) the goodwill of the businesses with which the Trademarks are associated and (iv) all causes of action arising prior to or after the date of the Intellectual Property Security Agreement for infringement of any of the Trademarks or unfair competition regarding the same (collectively, “Intellectual Property Collateral”);

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks, dated as of November 26, 2014, (the “Intellectual Property Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on November 26, 2014 at Reel/Frame 5409/0376;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined, herein shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Intellectual Property Security Agreement, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its lien on and security interest in and to all of the right, title and interest of such Agent in, to and under all the Intellectual Property Collateral arising under the Security Agreement and the Intellectual Property Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to the Intellectual Property Collateral under Security Agreement or the Intellectual Property Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Intellectual Property Security Agreement.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
