**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of October 7, 2021, by **ANTARES CAPITAL LP**, a Delaware limited partnership (in such capacity, together with its successors and assigns in such capacity, “Administrative Agent”) in favor of **MASERGY COMMUNICATIONS, INC.**, a Delaware corporation with an address at 2740 North Dallas Parkway, Suite 260, Plano, Texas 75093 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain second lien trademark security agreement dated November 5, 2018 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on November 5, 2018 at the United States Patent and Trademark Office at Reel 5938, Frame 0655.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of such Grantor’s Trademarks listed in Schedule A.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademarks of the Grantor, and assigns, transfers and conveys to Grantor any interest in such Trademarks.
