CONFIRMATORY ASSIGNMENT dated 05 October 2021

PARTIES

- 1 **SAFEGUARD MEDICAL HOLDCO, LLC** incorporated and registered in North Carolina whose registered office is at 5555 Harrisburg Industrial Park Drive, Harrisburg, North Carolina 28075, United States of America (the "Seller"); and
- 2 **RADIADERM LIMITED** incorporated and registered in England and Wales with company number 13210315 whose registered office is at 35 Ballards Lane, London, N3 1XW, United Kingdom (the "Buyer").

BACKGROUND

By the Main Agreement, the Seller has agreed to assign the IP Assets to the Buyer on the terms set out in this Agreement.

AGREED TERMS

1 INTERPRETATION

The following definitions and rules of interpretation apply in this Agreement.

1.1 Definitions:

- 1.1.1 "**Intellectual Property Rights**" means patents, rights to inventions, copyright and related rights, trade marks, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off, rights in designs, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world.
- 1.1.2 "**IP Assets**" means the Patents and Trade Marks
- 1.1.3 "**Main Agreement**" means an asset purchase agreement dated 26 March 2021 between the Seller and the Buyer.
- 1.1.4 "**Patents**" means the patents and the applications short particulars of which are set out in Part 1 of Schedule 1.
- 1.1.5 "**Trade Marks**" means the registered trade marks and the applications short particulars of which are set out in Part 2 of Schedule 1.
- 1.1.6 "**Transaction**" means the transaction contemplated under the Main Agreement.
- 1.2 Clause, Schedule and paragraph headings shall not affect the interpretation of this Agreement.
- 1.3 The Schedules form part of this Agreement and shall have effect as if set out in full in the body of this Agreement. Any reference to this Agreement includes the Schedules. References to clauses and Schedules are to the clauses of and Schedules to this Agreement.

2 **ASSIGNMENT**
2.1 Pursuant to and for the consideration set out in the Main Agreement (receipt of which the Seller expressly acknowledges), the Seller hereby assigns to the Buyer absolutely with full title guarantee all its right, title and interest in and to the IP Assets, including:

- 2.1.1 the absolute entitlement to any registrations granted pursuant to any of the applications comprised in the Patents and Trade Marks;
- 2.1.2 all goodwill attaching to the use of the Trade Marks by the Seller; and
- 2.1.3 the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the IP Assets whether occurring before, on, or after the date of this Agreement.

3 **FURTHER ASSURANCE**

3.1 The Seller shall, and shall use all reasonable endeavours to procure that any necessary third party shall, promptly execute and deliver such documents and perform such acts as may be required for the purpose of giving full effect to this Agreement.

4 **GOVERNING LAW**

This Agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the laws of the State of North Carolina.

5 **JURISDICTION**

Each party irrevocably agrees that the State or Federal courts of the State of North Carolina, with venue in, and if not in, then nearest to, Harrisburg, North Carolina shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this Agreement or its subject matter or formation.

This Agreement has been entered into on the date stated at the beginning of this document.
