PATENT AND TRADEMARK SECURITY AGREEMENT

**(Patents and Trademarks, including Registrations,
Applications and Licenses)**

PATENT AND TRADEMARK SECURITY AGREEMENT dated as of October 4, 2021, between AMERICAN DRYER LLC, an Illinois limited liability company, GREEN TURTLE AMERICAS LTD., a North Carolina corporation, ZURN PEX, INC., a Delaware corporation, ZURN INDUSTRIES, LLC, a Delaware limited liability company, JUST MANUFACTURING LLC, a Delaware limited liability company, WORLD DRYER CORPORATION, a Delaware corporation, ZURCO, INC., a Delaware corporation (the “Grantors”), and CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH as Administrative Agent and Collateral Agent.

WHEREAS, the Grantors own, or in the case of any Patent or Trademark Licenses are, as applicable, a party to, the Patent and Trademark Collateral (as defined below);

WHEREAS, RBS Global, Inc. (“Holdings”), Zurn Holdings, Inc. (“Zurn”) and Rexnord LLC, a Delaware limited liability company to be renamed “Zurn LLC” on or promptly after the Fourth Restatement Effective Date (“Zurn” and, together with Zurn Holdings, the “Borrowers”), the Lenders party thereto, and Credit Suisse AG, Cayman Islands Branch, as Administrative Agent, are parties to that certain Fourth Amended and Restated First Lien Credit Agreement dated as of October 4, 2021 (as amended from time to time, the “Credit Agreement”); and

WHEREAS, pursuant to (i) that certain Third Amended and Restated Guarantee and Collateral Agreement dated as of October 4, 2021 (as amended and/or supplemented from time to time, the “Guarantee and Collateral Agreement”) among Holdings, the Borrowers, the Guarantors party thereto and Credit Suisse AG, Cayman Islands Branch, as Administrative Agent and Collateral Agent for the Secured Parties referred to therein (in such capacities, together with its successors in such capacities, the “Grantee”) and (ii) certain other Security Documents (including this Patent and Trademark Security Agreement), the Grantors have guaranteed certain obligations of the Borrowers and secured such guarantee (the “Grantors’ Secured Guarantee”) by granting to the Grantee for the benefit of such Secured Parties a continuing security interest in personal property of the Grantors, including all right, title and interest of the Grantors in, to and under the Patent and Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to and upon the terms and conditions contained in the Guarantee and Collateral Agreement, the Grantors hereby grant to the Grantee, to secure the Grantors’ Secured Guarantee, a continuing security interest in all of the Grantors’ right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the “Patent and Trademark Collateral”), whether now owned or existing or hereafter acquired or arising:

(i) each Patent and each Trademark, including, without limitation, each registration or application therefor referred to in Schedule 1 hereto;

(ii) each Patent License and each Trademark License, including, without limitation, each Patent License and each Trademark License identified in Schedule 1 hereto; and

(iii) all proceeds of, revenues from, and accounts and general intangibles arising out of, the foregoing, including, without limitation, all proceeds of and revenues from any claim by the Grantors against third parties for past, present or future infringement of any Patent or Trademark (including, without limitation, any Patent or Trademark owned by the Grantors and identified in Schedule 1), and all rights and benefits of the Grantors under any Patent License or Trademark License (including, without limitation, any Patent License or Trademark License identified in Schedule 1).

The Grantors irrevocably constitute and appoint the Grantee and any officer or agent thereof, with full power of substitution, as its true and lawful attorney in fact with full power and authority in the name of the Grantors or in the Grantee's name, from time to time, in the Grantee's discretion, so long as any Event of Default shall have occurred and be continuing, to take with respect to the Patent and Trademark Collateral any and all appropriate action which the Grantors might take with respect to the Patent and Trademark Collateral and to execute any and all documents and instruments which may be necessary or desirable to carry out the terms of this Patent and Trademark Security Agreement and to accomplish the purposes hereof.


Except to the extent not prohibited by the Guarantee and Collateral Agreement or the Credit Agreement, the Grantors agree not to sell, license, exchange, assign or otherwise transfer or dispose of, or grant any rights with respect to, or mortgage or otherwise encumber, any of the Patent and Trademark Collateral.

The foregoing security interest is granted in conjunction with the security interests granted by the Grantors to the Grantee pursuant to the Guarantee and Collateral Agreement. Terms defined in the Guarantee and Collateral Agreement (or whose definitions are incorporated by reference in Section 1 of the Guarantee and Collateral Agreement) and not otherwise defined herein have, as used herein, the respective meanings provided for therein. The Grantors acknowledge and affirm that the rights and remedies of the Grantee with respect to the security interest in the Patent and Trademark Collateral granted hereby are more fully set forth in the Guarantee and Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Patent and Trademark Security Agreement is deemed to conflict with the Guarantee and Collateral Agreement, the Guarantee and Collateral Agreement shall govern.


