INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION

(Trademarks)

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION is made effective as of October 1, 2021, by and from EAST WEST BANK (“**Bank**”), under the Loan and Security Agreement, dated as of October 19, 2020, between EVERNOTE CORPORATION, a Delaware corporation (the “**Company**”), and Bank, to the Company as follows:

WHEREAS, the Company and Bank entered into the Intellectual Property Security Agreement, dated as of October 19, 2020 (the “**Intellectual Property Security Agreement**”; capitalized terms used but not defined herein shall have the meanings given them in the Intellectual Property Security Agreement);

WHEREAS, the Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on October 19, 2020, at Reel 7079 and Frame 0907 for trademarks;

WHEREAS, pursuant to the Intellectual Property Security Agreement, the Company granted Bank a security interest in all of the Company’s right, title and interest in, to and under the trademarks listed on the attached **Exhibit A** (the “**Trademarks**”) and all trademark applications and trademark registrations acquired or arising after the date of the Intellectual Property Security Agreement (collectively the “**Intellectual Property**”);

WHEREAS, the Company has or has caused to be paid and satisfied in full the obligations for which the security interest in the Intellectual Property was granted; and

WHEREAS, the Bank wishes to release its security interest in the Intellectual Property;


NOW, THEREFORE, the parties agree that Bank hereby releases any security interest it may have in the Intellectual Property and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns to the Company all right, title and interest in the Intellectual Property it may have in and to the foregoing without recourse to the Company. The Bank further agrees, for itself, its successors and assigns, to execute, at the Company’s expense, such further documents, and to perform such further lawful acts, as may reasonably be requested by the Company to effectuate this termination.
