THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release"), dated as of September 27, 2021, is delivered by LEVEL STRUCTURED CAPITAL I, L.P., a Delaware limited partnership, as Agent ("Lender"), in favor of PHOTOSHELTER, INC., a Delaware corporation ("Borrower").

RECITALS

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated February 28, 2019, by and among Borrower and Lender (the "Security Agreement"), recorded on March 4, 2019, at Reel No. 6580, Frame 0206, with the United States Patent and Trademark Office, Borrower granted a security interest in certain intellectual property in favor of Lender to secure certain debt owing from Borrower to Lender;

WHEREAS, Borrower has requested that Lender (i) terminate, release, and fully discharge the liens and interests of Lender in certain of Borrower's intellectual property as set forth in **Exhibit A** attached hereto (collectively, the "Intellectual Property"), and (ii) execute and deliver evidence of such termination and release for filing with the United States Patent and Trademark Office and other appropriate offices; and

WHEREAS, Lender has agreed to such release, termination, and discharge.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby:

1. releases, terminates, and discharges its security interests in the Intellectual Property, and reassigns to Borrower all right, title and interest of Lender in and to the Intellectual Property, including all goodwill associated therewith; and
2. authorizes and requests that this Release be recorded at the United States Patent and Trademark Office and all other appropriate offices.
