**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 1, 2021 (“Release”), is made by Bank of America, N.A., as Administrative Agent (“Administrative Agent”) in favor of Southern Felt Company, Inc., a South Carolina corporation (“Obligor”).

WHEREAS, pursuant to that certain Amended and Restated Security Agreement dated as of August 31, 2018 (as amended, restated, supplemented or otherwise modified and in effect from time to time, the “Security Agreement”) by and among the Obligor, Administrative Agent, and others party thereto, and the Trademark Collateral Assignment and Security Agreement dated as of August 31, 2018 (“Trademark Security Agreement”) by and among the Obligor and Administrative Agent, Obligor granted to the Administrative Agent, for the ratable benefit of itself and the Secured Parties, a continuing security interest in and first priority lien on the Pledged Trademarks and pledged and mortgaged the Pledged Trademarks to the Administrative Agent, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, the “Trademark Collateral”); and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on August 31, 2018 at Reel 6428 Frame 0112.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of itself and the Secured Parties, and Obligor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Administrative Agent, on behalf of itself and the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in and first priority lien on the Trademark Collateral and pledge and mortgage of the Trademark Collateral, including the trademark registrations and trademark applications listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Obligor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of itself and the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
