Michelle Wine Estates Ltd., a Washington corporation (the "Corporation"), into a Washington limited liability company (the "Limited Liability Company") pursuant to Chapter 23.15 of the Revised Code of Washington, does hereby certify as follows:

FIRST: The jurisdiction where the Corporation first formed is Washington.

SECOND: The jurisdiction of the Corporation immediately prior to filing these Articles of Conversion is Washington.

THIRD: The date the Corporation first formed is January 2, 1973.



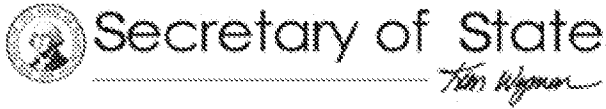
