**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Termination”), dated as of October 12, 2021, is executed by **ARES CAPITAL CORPORATION**, a Maryland corporation, in its capacity as administrative agent and collateral agent for the Secured Parties (“Administrative Agent”), and in favor of **MINERVA SURGICAL, INC.**, a Delaware corporation (the “Grantor”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Trademark Security Agreement, dated as of December 30, 2019 (the “Security Agreement”), executed by Grantor in favor of Administrative Agent, Grantor granted to Administrative Agent a security interest in the Trademark Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on December 31, 2019, at Reel 6828 and Frame 0568, to evidence the security interest granted under the Security Agreement.

C. Administrative Agent agrees to terminate and release its security interest in the Trademark Collateral specified below.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby agrees as follows:

(a) Administrative Agent expressly terminates and releases all of Administrative Agent’s right, title and interest in pursuant to the Security Agreement, to and under the following (collectively, the “Trademark Collateral”):

(i) all Trademarks and IP License, excluding any Excluded Collateral, to which the Grantor is a party including those referred to on Schedule I;

(ii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each IP License; and

(iii) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any IP License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any IP License.

(b) Administrative Agent represents and warrants that it has the full power and authority to execute this Termination.

(c) Administrative Agent authorizes and requests the Trademark Division of the United States Patent and Trademark Office to record this Termination.
