**TERMINATION OF SECURITY INTEREST AND RELEASE OF
INTELLECTUAL PROPERTY COLLATERAL**

THIS TERMINATION OF SECURITY INTEREST AND RELEASE OF INTELLECTUAL PROPERTY COLLATERAL (the "Release") is made effective as of October 1, 2021 (the "Effective Date") by Fifth Third Bank, National Association, successor in interest to MB Financial Bank, N.A., successor in interest to American Chartered Bank (the "Releasing Party").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated December 20, 2016 (the "IP Security Agreement"), Elenco Electronics, Inc., an Illinois corporation (the "Grantor") granted the Releasing Party a security interest in, to and under IP Collateral (as defined in the IP Security Agreement), that included the patents listed in Exhibit A and the trademark registrations listed in Exhibit B, each attached hereto, and which was recorded in the United States Patent and Trademark Office on February 3, 2017 at Reel 005981, Frame 0250.

WHEREAS, the IP Security Agreement was subsequently re-recorded with United States Patent and Trademark Office on February 13, 2017 at Reel 005987, Frame 0960.



The Grantor (and any successor to the Grantor, including any person or entity hereafter holding any right, title or interest in and to the IP Collateral of the Grantor) is hereby authorized to record this Release with the United States Patent and Trademark Office.
