RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement (this “Release”) is made effective as of November 25, 2020 by BANKUNITED, N.A., as Agent for the Lenders (the “Secured Party”) to BIG TRUCK RENTAL, LLC, a Florida limited liability company (the “Grantor”), as follows:

WHEREAS, on December 30, 2015, Grantor and the Secured Party entered into that certain U.S. Security Agreement (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), and on December 30, 2015, the Grantor and the Secured Party entered into that certain Agreement (Trademark) (the “Confirmatory Grant”);

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Secured Party, among other collateral, a continuing security interest in all of the Grantor’s right, title and interest in, to and under its trademarks, including goodwill, including but not limited to the trademarks listed on the attached Schedule A;

WHEREAS, the Confirmatory Grant was recorded in the United States Patent and Trademark Office (the “USPTO”) on the dates and on the reels and frames set forth on Schedule A hereto; and

WHEREAS, the Secured Party wishes to release its security interest in the trademarks listed on Schedule A and retransfer and reassign to the Grantor without recourse any of the Secured Party’s right, title and interest in and to the trademarks listed on Schedule A.

NOW, THEREFORE, the Secured Party hereby releases, terminates and discharges any security interest it may have under the Security Agreement or the Confirmatory Grant in the trademarks listed on Schedule A, and reassigns any and all right, title and interest it may have in and to the trademarks listed on Schedule A without recourse to the Grantor, and such security interest shall hereby terminate, cease and become void; and the Secured Party hereby consents to the recording of this Release with the USPTO.
