RELEASE OF A SECURITY INTEREST -- TRADEMARKS

October 13, 2021

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of Oct 30, 2019, recorded in the United States Patent and Trademark Office at Reel/Frame 6782/0853 (the "Trademark Security Agreement"), The Shade Store, LLC, a Delaware limited liability company (the "Releasee") granted to JEFFERIES FINANCE LLC, as collateral agent for the ratable benefit of the Secured Parties (the "Releasor"), a continuing security interest in all right, title and interest of the Releasee in, to and under the United States Trademarks listed on the attached Schedule A (the "Trademarks"), together with (a) all extensions and renewals thereof, (b) all income, fees, royalties, damages and payments now or hereafter due and/or payable with respect thereto, including damages and payments for past, present or future infringements and dilutions thereof or injury to the goodwill associated therewith, and (c) the right to sue for past, present and future infringements and dilutions thereof or injury to the goodwill associated therewith (with all of the Releasee's rights listed above being collectively referred to as the "Collateral") to secure the payment, performance and observance of the Secured Obligations;

WHEREAS, the Releasee has satisfied its Secured Obligations; and

WHEREAS, the Releasee has requested and the Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Collateral.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. The Releasor hereby, without any representation and warranty and without any recourse to the Releasor, releases, relinquishes and discharges all of its security interest in the Collateral.
3. Choice of Law. This Release shall be governed by and shall be construed and enforced in accordance with the laws of the State of New York.
4. Counterparts. This Release may be executed in any number of counterparts, and telecopied signatures (or signatures delivered via electronic mail or "pdf") shall be enforceable as originals.
