TRADEMARK ASSIGNMENT

Effective as of October 30, 2019

WHEREAS, CMA Marketing Corp., a New York corporation having a principal office at 40 S.E. 5th Street, Suite 503, Boca Raton (“CMA”), Florida, originally owned the entire interest in and to the trademarks listed below (the “Marks”); and

WHEREAS, upon winding up its affairs, CMA transferred the Marks, as of March 11, 2010, to CMA’s shareholder Claude Ades, a natural person with an address of 140 S.E. 5th Avenue, Boca Raton, Florida (“Claude”); and

WHEREAS, Claude passed away on July 31, 2018; and

WHEREAS, Claude’s Last Will and Testament, dated November 3, 2017, (the “Will”) was probated in the Circuit Court for Palm Beach County, Florida, as “Estate of Claude M. Ades,” File Number 50-2018-CP-5418 (the “Estate”), naming Marc Ades as Claude’s Personal Representative of the Estate (the “PR”); and

WHEREAS, by operation of law, the Estate succeeded to Claude’s interests in the Marks; and

WHEREAS, the Estate and the PR, on behalf of Claude, desire to effectuate the disposition set forth in the Will, namely for Marc Ades, a natural person, in his individual capacity, with an address at 30 Bay 29th Street, 2B Brooklyn, NY 11214 (“Marc”), to obtain ownership of the Marks, and Marc desires to acquire the entire interest in and to the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Claude, by and through the PR, and through the Estate, does hereby sell, distribute, assign, grant, bargain, transfer, convey, set over and confirm unto Marc, his successors and assigns, all of the right, title and interest Claude had, and thus the Estate may have, in and to the Marks, including the common law rights, rights respecting registration, and certificates of registration registered at the United States Patent and Trademark Office listed below:


