NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Notice of Release") is made as of October 12, 2021 ("Effective Date"), by ZIONS BANCORPORATION, N.A. dba National Bank of Arizona, as Agent for the Lenders ("Agent", and in its capacity as Agent for the Lenders under the Security Agreement, "Secured Party"), in favor of BROOKLYN BEDDING LLC, an Arizona limited liability company ("Debtor").

WHEREAS, pursuant to the terms and conditions of that certain Continuing Security Agreement dated as of December 31, 2020 (the "Security Agreement"), Debtor assigned, transferred and conveyed to the Secured Party a security interest in all of Debtor's right, title, and interests in and to the "Collateral" as defined therein;

WHEREAS, the security interests of Secured Party in the trademark registrations and trademark applications listed on Schedule A hereto (collectively, the "Released Trademark Collateral") was recorded with the United States Patent and Trademark Office ("USPTO") at Reel 7160, Frame 0760;

WHEREAS, Secured Party has agreed to release its liens on all of the Collateral, including, without limitation, the Released Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby covenants and agrees as follows:

1. Secured Party's mortgage, pledge, hypothecation, and liens on, and security interest in, the Released Trademark Collateral is hereby terminated and released.

2. To the extent Secured Party retains any such interests, Secured Party hereby assigns, transfers and conveys to Debtor, all of Secured Party's rights, title and interests, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interests and collateral assignment in the Released Trademark Collateral. Such assignment, transfer and conveyance by Secured Party is made without any representation or warranty (express or implied) by Secured Party.

3. Delivery of an executed signature page to this Notice of Release by facsimile or other electronic transmission shall be effective as delivery of a manually executed signature page of this Notice of Release.


