**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST dated as of September 2, 2021 is made by KEYBANK NATIONAL ASSOCIATION, as Agent (in such capacity, together with its successors and permitted assigns in such capacity, the "Lender") of certain United States Trademark Security Agreement, dated as of October 17, 2019 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") between BRIDGELAND DEVELOPMENT, LP, a Maryland limited partnership (the "Grantor") and the Lender. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded at the United States Patent and Trademark Office ("USPTO") on October 18, 2019 at Reel 6774 and Frame 0323, the Grantor granted to the Lender a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral, including but not limited to those trademark applications and registrations set forth on the attached Schedule I.

WHEREAS, the Grantor has requested and the Lender has agreed to provide a document suitable for recording in the USPTO evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Lender in the Trademark Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Trademark Collateral, if and to the extent that Lender has acquired any right, title or interest in the Trademark Collateral.
