**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of October 12, 2021, is made by BC PARTNERS LENDING CORP. and GREAT LAKES KCAP FUNDING I, LLC, as co-agents for the Lenders and each other Lender Party (each individually, a “Co-Agent”, and collectively referred to as “Agent” or “BCP”) in favor of LOCATION SERVICES, LLC, (the “Obligor”).

WHEREAS, pursuant to the ABL Credit and Security Agreement, dated as of November 7, 2019, as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the Obligor granted a first priority security interest to the Agent in, and to, all Obligor’s now owned or existing Trademarks (as defined in the IP Security Agreement (as defined below)), including as set forth on Schedule 1 attached hereto (the “Trademarks”); and

WHEREAS, the Agent executed a Trademark Security Agreement, dated as of November 7, 2019, (“IP Security Agreement”), which was duly recorded on November 7, 2019, at Reel 6790 Frame 0982 Document No. 900522517 in the United States Patent and Trademark Office; and


WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Obligor and to dissolve those liens and encumbrances created by the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the Trademarks, (b) release its security interest in the Trademarks and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Trademarks.


