**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of July 26, 2021, is made by **JPMORGAN CHASE BANK, N.A.**, as Agent (the "Administrative Agent"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Credit Agreement, dated as of May 15, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among GlobalTranz Enterprises, LLC, a Delaware limited liability company, as the Borrower, Sedona Intermediate Inc., a Delaware corporation, as Holdings, the Lenders from time to time party thereto and Administrative Agent, the Lenders agreed to make loans and extend other financial accommodations to or for the benefit of the Borrowers;

**WHEREAS**, the Borrower, Holdings and the other Loan Parties entered into that certain Pledge and Security Agreement dated as of May 15, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Administrative Agent for itself and the other Lenders;

**WHEREAS**, in connection with the Credit Agreement, Security Agreement and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "IP Security Agreements"), certain Loan Parties (collectively, the "Grantors" and each a "Grantor") granted security interests in the IP Collateral (as defined in the IP Security Agreements), including those listed on Annex I attached hereto; and

**WHEREAS**, the IP Security Agreements were recorded in the United States Patent and Trademark Office ("USPTO") or the United States Copyright Office ("USCO"), as applicable, on the dates and on the reels/frames or volume/document no., as applicable, set forth on Annex I attached hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby **RELEASES**, terminates and discharges, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the IP Collateral (as defined in the IP Security Agreements), including those described on Annex I attached hereto, whether granted pursuant to the Security Agreement, the IP Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in, to and under the IP Collateral to the relevant Grantor.


The Administrative Agent agrees, at the Grantors' sole expense, to cooperate with the Grantors and take all further actions and provide to the Grantors and their successors, assigns and legal representatives with all such cooperation, assistance, information and additional authorization, including, without limitation, the execution and delivery of any and all further documents or other instruments, in each case as reasonably required or desirable to effect the release of the Administrative Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
