RELEASE OF SECURITY INTEREST IN TRADEMARKS, effective as of September 30, 2021, given by COÖPERATIEVE RABOBANK U.A., NEW YORK BRANCH (formerly known as COÖPERATIEVE CENTRALE RAIFFEISEN-BOERENLEENBANK B.A. "Rabobank Nederland", New York Branch), in its capacity as administrative agent for the Lenders (in such capacity, the "Administrative Agent"), with its principal offices at 245 Park Avenue, New York, New York 10167, to Eight O'Clock Coffee Holdings, Inc., a Delaware corporation ("Parent") and Eight O'Clock Coffee Company, a Delaware corporation ("EOC"), ("EOC," jointly and severally with Parent, the "Grantors," and each individually, a "Grantor"), as follows:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 28, 2013 ("Security Agreement"), made by each Grantor in favor of Administrative Agent, a security interest was granted by EOC to Administrative Agent in certain trademarks, trademark applications and tradenames (the "Trademarks"), including without limitation those items listed on Schedule 1 hereto;

WHEREAS, Administrative Agent now desires to release the entirety of its security interest in the Trademarks;


