**TERMINATION AND RELEASE OF  
PATENT AND TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT** (this "Termination") is dated as of October 14, 2021, and made by WELLS FARGO BANK, NATIONAL ASSOCIATION, having an office at 1800 Century Park East, Suite 1300, Los Angeles, California 90067 ("Wells Fargo"), to M&G DURA-VENT, INC., a Delaware corporation (the "Company"), having an office at 877 Cotting Court, Vacaville, California 95688.

WHEREAS, Company and Wells Fargo entered into that certain Patent and Trademark Security Agreement, dated August 31, 2010 (as amended, the "Security Agreement"), in which a security interest was granted by Company in favor of Wells Fargo in certain Patents and Trademarks (as such terms are defined in the Security Agreement);

WHEREAS, the Security Agreement was originally recorded in the Patent Division of the United States Patent and Trademark Office on September 27, 2010, at Reel 025039, Frame 0757;

WHEREAS, the Security Agreement was originally recorded in the Trademark Division of the United States Patent and Trademark Office on September 27, 2010, at Reel 004284, Frame 0545; and

WHEREAS, Wells Fargo now desires to terminate and release the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Wells Fargo hereby states as follows:

1. Definitions. The terms "Patents" and "Trademarks", as used herein, shall have the meanings set forth in the Security Agreement and shall mean and include all of the Company's right, title and interest of every kind and nature as of the date hereof, including in the patents listed on Exhibit A attached hereto and the trademarks listed on Exhibit B attached hereto.

2. Release of Security Interest. Wells Fargo hereby terminates the Security Agreement, and terminates, releases and discharges its security interest in the Patents and Trademarks and reassigns to the Company all right, title and interest it may have in and to the Patents and Trademarks without recourse and without any representation or warranty.
