ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS (this "Assignment"), dated as of September 17, 2021 is made by **VR EXIT LLC**, a Delaware limited liability company ("Assignor") with a place of business at 2506 Barcelona Drive, Fort Lauderdale, FL 33301, to **HYPER REALITY PARTNERS, LLC**, a Delaware limited liability company ("Assignee") having an address of c/o Ricardo Fontg, Esq., 330 West 47th Street, Suite 250, Kansas City, MO 64112.

RECITALS:

WHEREAS, The Void, LLC, a Delaware limited liability company ("Borrower") Assignor had an ownership interest in the Trademarks and Trademark Applications (the "Trademarks and Trademark Applications") described on **Exhibit 1** attached hereto; and

WHEREAS, Borrower and VR Boom LLC, a Delaware limited liability company, ("Lender") are parties to, inter alia, that certain Loan and Security Agreement, dated as of August 19, 2019 (as amended, restated, amended and restated or otherwise modified or supplemented from time to time, the "Loan Agreement") and the other loan documents executed in connection with the Loan Agreement and the loan made in connection therewith (together with the Loan Agreement, collectively, the "Loan Documents"); and

WHEREAS, Borrower granted to Lender a security interest in substantially all of Borrower's property and assets including but not limited to the Trademarks and Trademark Applications and the goodwill associated therewith, and the other trademarks and trademark applications and service marks and service mark applications owned by the Borrower and all goodwill arising out of or relating thereto (collectively, the "Collateral") to secure the performance of its obligations under the Loan Documents; and

WHEREAS, one or more Events of Default (as defined in the Loan Documents) occurred under the Loan Documents and the Lender exercised its rights and remedies under the Loan Documents including the sale of the Collateral pursuant to the Uniform Commercial Code; and

WHEREAS, in connection with Lender's public sale of the Collateral, Borrower assigned its right, title and interest in and to the Trademarks and Trademark Applications listed on Exhibit 1 to Assignor, Assignor became the owner of Borrower's right, title and interest in and to such Trademarks and Trademark Applications (the "Trademark IP") following a foreclosure by Lender, and Assignor has filed the assignment of the Trademarks with the U.S. Patent and Trademark Office ("USPTO").

WHEREAS, Assignor is hereby assigning the Trademark IP to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of are hereby acknowledged, Assignor hereby agrees as follows:

1. Assignment of Trademarks. Assignor hereby without any representation of warranty of any nature except as specifically set forth in section 3 hereof indefeasibly and irrevocably assigns, transfers, and conveys to the Assignee all of Assignor's right, title and interest in and to (i) the Trademark IP, all other trademarks and trademark applications and all other service marks and service mark applications owned by Assignor as assignee from Borrower, (ii) the registrations and common law rights therefor, (iii) all goodwill of the business of Assignor connected with the use of, or otherwise symbolized by, the Trademark IP and all other trademarks and trademark applications and service marks and service mark applications of Assignor as assignee from Borrower, and (iv) all rights to sue for past, present and future infringement and misappropriations of the Trademark IP and colorable imitations thereof, and of all other trademarks and trademark applications, service marks and service mark applications of Assignor as assignee from Borrower, (v) if any, all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing, and (vi) if any, all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Filing and Recordation. Assignee is hereby authorized to file or record this Assignment and any other instrument in such public offices and with such governmental authorities, including the United States Patent and Trademark Office, as Assignee may determine from time to time for the purpose of evidencing the foregoing assignment.

3. Assignor Representations.

(a) Assignor represents that no rights in the Trademark IP or other trademarks and service marks of Assignor as assignee from Borrower, or any goodwill associated therewith or rights to sue for past, present or future infringement, are retained by Assignor.

(b) Assignor represents that no assignment, grant, mortgage, license or other agreement affecting the rights and property conveyed herein has been made by Assignor to others, and that full right to convey the same expressed herein is possessed by Assignor. Notwithstanding the foregoing:

(i) certain trademark registrations or applications described on Exhibit 1 are designated as abandoned, inactive or opposed, and Assignee accepts this assignment with full knowledge of these matters.

(ii) Assignor may have no interest in the mark "The Moth and the Flame" notwithstanding its inclusion in Exhibit 1. Assignor is unaware of any transfer of rights to the mark from its registered owner to Borrower, which nonetheless listed it as part of the Trademark IP. It is listed as "inactive" because counsel for Assignor never received a power of attorney authorizing it to maintain it.

4. Choice of Law. The laws of the State of New York shall govern the interpretation, validity, performance and enforcement of this Assignment.

5. Execution in Counterparts. This Assignment may be executed in multiple counterparts which together shall constitute one Assignment. Facsimile scan, and electronic signatures shall be valid as originals.
