CONFIRMATION OF TRADEMARK ASSIGNMENT

This Confirmation of Trademark Assignment ("*Assignment*") is entered into by and between Mercedes-Benz Investment Company LLC, a Delaware limited liability company ("*MBIC*") and Mooritch Acquisitions Inc., a Delaware corporation ("*Mooritch*").

WHEREAS, pursuant to a prior Asset Transfer Agreement between and among MBIC and Mooritch effective **December 18, 2020**, (the "*Asset Transfer Agreement*"), certain intellectual property rights, including without limitation all rights, title and interest in and to the CoROS Marks (as defined below), were assigned to Mooritch.

NOW, THEREFORE, MBIC and Mooritch confirm that:

"*CoROS Marks*" means all of CoROS, Corp.'s trademarks, service marks, trade names, trade dress, logos, designs and slogans, in word mark, stylized and/or design formats, including without limitation CoROS's trademark registrations and applications and any and all of CoROS's common law rights in the aforementioned items, together with all goodwill associated with and symbolized by the aforementioned items, including without limitation the marks identified in Schedule 1 attached hereto and all of the goodwill associated with and symbolized by such marks.

Effective December 18, 2020, MBIC assigned and transferred, and Mooritch received and accepted, all of MBIC's rights, title and interest throughout the world in and to the CoROS Marks and all the rights, claims and privileges pertaining to the CoROS Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the CoROS Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of MBIC in all matters related thereto.

MBIC hereby authorizes and requests that the relevant officials of the relevant countries implement this Assignment.

IN WITNESS WHEREOF, MBIC and Mooritch confirm that this Assignment was made as of the effective date of the Asset Transfer Agreement referenced above.
