**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of October 15, 2021, is made by CITIBANK, N.A., in its capacity as collateral agent for itself and the other Secured Parties (in such capacity, the "Collateral Agent"), in favor of the parties identified as "Grantors" on Schedule A hereto (each a "Grantor" and collectively the "Grantors"). Capitalized terms used by not defined herein shall have the meanings set forth in the Trademark Security Agreement, whether defined directly therein or by reference to another agreement.

WITNESSETH:

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of February 9, 2021, by and among the Loan Parties party thereto and the Collateral Agent (as may have been amended, restated, supplemented, modified or otherwise changed form time to time, the "Security Agreement"), the Grantors executed and delivered a Notice of Grant of Security Interest in Trademarks, dated February 9, 2021 (the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office, with respect to each Grantor, at the Reel/Frame numbers identified for such Grantor on Schedule A hereto;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor pledged, collaterally assigned, and Granted to the Collateral Agent for the benefit of the Secured Parties a continuing security interest (the "Security Interest") in (i) the trademarks and services marks listed on Schedule B hereto, (ii) all extensions, modifications and renewals thereof, (iii) the goodwill of such Grantor's business symbolized by the foregoing or connected therewith, (iv) all proceeds thereof, including any income, license fees, royalties, damages, and payments then and thereafter due or payable under and with respect thereto, including payments under all licenses entered into in connection therewith and damages and payments for past, present or future infringements, dilutions and other violations thereof, (v) the right to sue for past, present and future infringements, dilutions and other violations thereof, and (vi) all of such Grantor's rights corresponding thereto throughout the world (collectively, the "Trademark Collateral"); and

WHEREAS, the Collateral Agent now desires to terminate the Trademark Security Agreement and terminate and release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels, releases, relinquishes and discharges the Security Interest in the Trademark Collateral, and (iii) reassigns to each Grantor any right, title or interest, if any, the Collateral Agent may have in the Trademark Collateral of such Grantor, in each case without recourse to the Collateral Agent, and without representation or warranty of any kind. Each Grantor, and any successor to such Grantor (including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral of such Grantor) is hereby authorized to record this Release with the United States Patent and Trademark Office.
