ASSIGNMENT OF TRADEMARKS AND TRADE NAMES

This Assignment of Trademarks and Trade Names ("Assignment") is made and entered into as of this 30th day of December, 2010 by and between SDI Investment Company, a Delaware corporation with its only office at 300 Delaware Avenue, Suite 900, Wilmington, Delaware 19801 ("SDI Investment") and Steel Dynamics, Inc., an Indiana corporation, with its principal place of business at 7575 West Jefferson Blvd., Fort Wayne, Indiana 46804 ("SDI") under the following circumstances:

- A. SDI adopted and used certain trademarks and trade names, as more specifically described in Exhibit A (hereinafter referred to as "Intellectual Property"), in connection with producing, marketing, selling and distributing steel and steel products.
- B. On or about February 28, 2000, SDI assigned its Intellectual Property to SDI Investment pursuant to the terms and conditions of an Assignment Agreement and SDI Investment licensed said marks back to SDI pursuant to the terms of a License and Royalty Agreement as amended and restated from time to time.
- C. SDI Investment intends to dissolve effective as of December 31, 2010 and in connection with the dissolution process, SDI Investment wishes to assign the Intellectual Property back to SDI.

For and in consideration of the premises, and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:


1. Assignment. SDI Investment hereby conveys, transfers, assigns and delivers to SDI all of SDI Investment's right, title and interest of whatever kind in and to the Intellectual Property, together with (i) the goodwill associated with any of the Intellectual Property; (ii) all income, royalties and damages hereafter due or payable to SDI Investment with respect to the Intellectual Property, including, without limitation, damages and payments for past and future infringements and misappropriation of the Intellectual Property; and (iii) all rights to sue for past, present and future infringements or misappropriation of the Intellectual Property.
2. Execution of Further Instruments. SDI Investment hereby covenants and agrees that it will execute all instruments and other documents and authorizations and take all other actions that may be necessary for securing, completing or investing in SDI's full right, title and interest in the Intellectual Property.

3. Acceptance of Assignment. SDI hereby accepts the Assignment of the Intellectual Property and assumes any and all duties with respect to the recording of the Assignments with the United States Patent and Trademark Office and future maintenance of the registrations of the marks.
4. Applicable Law. This Assignment shall be governed by and construed under the laws of the State of Indiana without regard to its conflict of laws principles.


