**RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of October 15, 2021 (the “Effective Date”), is made by Jefferies Finance LLC, in its capacity as Collateral Agent (the “Agent”), in favor of the grantors identified on the signature pages hereto (the “Grantors”).

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of December 1, 2017, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the applicable Grantors executed and delivered (i) a Grant Of Second Lien Security Interest In Trademark Rights, dated as of December 1, 2017 (the “2017 Trademark Security Agreement”), (ii) a Second Lien Grant Of Security Interest In Trademark Rights, dated as of December 21, 2018 (the “2018 Trademark Security Agreement”), (iii) a Second Lien Grant Of Security Interest In Trademark Rights, dated as of January 8, 2020 (the “Jan. 2020 Trademark Security Agreement”) and (iv) a Second Lien Grant Of Security Interest In Trademark Rights, dated as of July 31, 2020 (the “July 2020 Trademark Security Agreement”, and, together with the 2017 Trademark Security Agreement, the 2018 Copyright Security Agreement and the Jan. 2020 Trademark Security Agreement, the “Trademark Security Agreements”), each for recordal with the United States Patent and Trademark Office;

WHEREAS, (i) the 2017 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 5, 2017 at Reel/Frame 6220/0923, (ii) the 2018 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 31, 2019 at Reel/Frame 6513/0163, (iii) the Jan. 2020 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 8, 2020 at Reel/Frame 6833/0752 and (iv) the July 2020 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 3, 2020 at Reel/Frame 7013/0124;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the applicable Trademark Security Agreement, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Collateral, including the trademark registrations and applications set forth Schedule A attached hereto, arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
